## **DP/VR LSD Committee Meeting Minutes**

## 1 Call to Order

Dave Chaulk called the meeting to order at 7:04pm and declared a quorum was present.

## **Confirmation of Agreement on Electronic Meeting**

Due to restrictions on in-person meetings set out by The Government of Newfoundland and Labrador, this meeting was proposed to go ahead as a video call. Wanda Highmore made a motion that committee members agree to accept and continue with this format. Seconded by Jeff Fifield. A Vote was taken, and the motion carried.

## Acceptance of Minutes of Meeting held September 28, 2020

#### **Financial Statement**

Kevin O'Regan updated the financial position of the LSD. With current liabilities including the Jan 31,2021 snowclearing payment, the LSD has a surplus of just under \$ 16,000.00.

#### 2021 Fees

Jeff Fifield made a motion to set the fees for 2021 as the same structure of 2020, that being an Annual Road Fee of \$ 400.00, with a \$ 100.00 discount available if paid in full by March 31, 2021. Confirmed that payment to the Town of Holyrood would remail at \$ 45.00 per property. Seconded by Wanda Highmore. A vote was taken and the motion carried.

#### **Roads Update**

Dave Chaulk reported on the current operations of road work.

Roads are in rough shape due to heavy rains through the fall. They need some touch up work. Dave has been in touch with our contractor, and there is a culvert on Marshland Trail in need of replacement. While that work is being completed, and there is equipment on site, a touch up grade to deal with the potholes can be completed. Quote of \$ 12,000. 00 to complete the work. John Hussey made a motion to proceed with the work as outlined. Seconded by Jeff Fifield. A vote was taken and the motion carried.

#### 911 Civic Address Project

Due to the inability to collaborate on the maps, this project will be deferred to the spring.

#### AGM Discussion

There was discussion around the challenges of holding an AGM with COVID-19 restrictions. It was agreed that the 2020 Annual General Meeting would be held by 'Zoom' on Tuesday, March 9, 2021. This information would be shared with statements and website.
